✓ **REJECT** on **REF-90**

The primary purpose of the referendum is to give voters an opportunity to approve or reject laws either proposed or enacted by the Legislature. Referendum Measures are laws recently passed by the State Legislature and placed on the ballot by referendum petition. Referendum 90 was filed by Parents for Safe Schools on 3/13/2020, to repeal or “REJECT” SB5395, the Comprehensive Sexual Health Education bill (CSE) passed by Majority Democrats during the 2020 Legislative Session and signed into law by WA State Governor Jay Inslee, on 3/27/2020. R-90 qualified for the 2020 General Election ballot after gathering a record-breaking 264,000 signatures.

WHY VOTE “REJECT” ON REFERENDUM 90?

If Voters **REJECT** R-90

- Returns sex education curriculum and content control to local school boards and parents.
- Less danger for children to be sexualized.
- Less danger for sexually explicit illustrations that sexualize young children.
- Young children won't be required to learn about affirmative consent for sexual activity.
- Unscientific biology and gender ideology will not be required or taught.
- Children will not be robbed of innocence.
- CSE is REJECTED by Evangelicals, Catholics, and socially conservative faith-based, family-honoring organizations and people of good will.
- Expect a decrease in minors having abortions and gender transition surgeries without parents' knowledge or consent.

If Voters **APPROVE** R-90

- Takes away local control and gives it to the Office of Superintendent of Public Instruction (OSPI)
- Increased danger for sexualizing children as young as Kindergarten.
- Allows use of pornographic illustrations to introduce and coach children in how to engage in alternative sex acts and activities.
- Unscientific biology and gender ideology will be required and taught.
- Mandates that children be taught how to ask for consent for sexual activity.
- Young children will be systematically stripped of their innocence.
- CSE is APPROVED by Planned Parenthood, LGBTQ and other anti-Christian organizations.
- Expect increase in minors having abortions and gender transition surgeries without parents' knowledge or consent.
